#### **Costume Cutter**

The post of Costume Cutter is offered on a full time permanent basis.

#### Salary

The salary for the post is £22,339. The salary is paid monthly by credit transfer on the last Friday of each month.

#### **Hours of work**

The normal hours are 40 per week to be worked flexibly across Monday to Saturday in agreement with your manager. We will endeavour to schedule basic hours over 5 days where possible. The role will also require some evening hours during production periods. Any hours in addition to your normal hours are to be agreed in advance.

Where the number of hours worked in any one week exceeds 40, time off in lieu (TOIL) will be accrued and taken at a time agreed with your line manager.

#### **Probationary & Notice Period**

The probationary period for this post is 6 months. The notice period during the probationary period is 2 weeks. Following successful completion of the probationary period the notice period is 4 weeks.

#### **Holiday Entitlement**

The annual holiday entitlement for this post is 20 days plus bank holidays. Holiday increases after 3 and 5 years' continuous service.

#### General

All eligible staff are automatically opted in for the New Vic's basic pension scheme under auto enrolment legislation. All offers of employment are subject to the candidate being able to provide suitable proof of their eligibility to work in the UK and references.

#### **Work Location**

The role will be based at the New Vic but may occasionally require work at other venues and locations, typically but not specific to, touring productions.

#### **Costume Cutter**

Responsible to: Head of Production, Head of Costume

#### **Role Purpose**

Working as part of the Costume Production Team, the Costume Cutter will ensure effective and efficient lead and support in the manufacturing of any costume required from initial pattern cutting and draping, through to final completion.

Alongside the other members of the Costume Department, the Costume Cutter will assist the Head of Costume in coordinating and monitoring the rotation and turnaround of costume production according to workload and staff availability; supporting with the planning of the department and assuring the meeting of deadlines throughout production and rehearsal periods.

This is a full time role that requires flexibility with occasional evening and weekend availability - catering mainly for specific fitting, rehearsal and tech schedules as arranged by the Head of Costume and Production Manager.

In addition to this role, the Costume Department consists of The Head of Costume, 2 part time Cutters, 2 part time Costume Technicians and, to run and maintain shows post production, a full time Wardrobe Technician.

All members of the Costume Department are expected to work to high standards and production values - respecting the responsibility for meeting deadlines and maintaining a positive work ethic.

#### **General Duties**

- To primarily cut, fit and produce costumes for all New Vic main house productions working individually and as a team.
- To produce costume according to the Designer and Directors requirements - both visually and practically for purpose and functionality, working closely with the Head of Costume to achieve this.
- To assist in the general prep of productions that require an approach other than cutting i.e. pulling, fitting, adapting and altering costume from the New Vic store and any other sources.
- To produce both soft and more prop based costume depending on skill set.
- To assist the Head of Costume during tech periods / sessions as and when required.
- To help keep the department functional and with a sustainable and realistic workload according to contracted / available hours and budgets.
- To assist the Wardrobe Technician with the more considerable running show alterations and repairs if required.

#### As a member of New Vic staff:

- Be a part of the New Vic team and attend company meetings as required
- · Attend training as required
- Comply and contribute to all Company Policies and Procedures including Health and Safety, Equal Opportunities, Safeguarding and Data Protection

- Be an advocate for the theatre and act always in the best interest of the New Vic
- Any other duties as may reasonably be required, that
  may assist the company in achieving its business
  objectives. Such tasks will not be of an unreasonable
  nature and shall commensurate with the level of the
  post.

The above accountabilities are not exhaustive and may vary without changing the character of the job or level of responsibility.



#### **Costume Cutter Person Specification**

We are looking for the following skills and experience:

#### **Essential Criteria**

- Demonstrable training and commercial experience in pattern cutting and costume construction, ideally but not solely within a workroom environment.
- Versatility in costume production other than flat work i.e. drapery and tailoring.
- Experience in more prop based costume and use of materials other than fabric.
- Understanding in the differences between clothing and costume production.
- Knowledge of more traditional period costume techniques and adapting to a commercial method with budget and time constraints.
- Ability to work on several items at the same time with a knowledge of time constraints and efficient production techniques.
- Good team and time management, etiquette and understanding of restraints / limitations within production timetables.
- Working as a team and individually.
- Understanding the nature of a Costume Department and adapting to its show specific working - practically and professionally.

#### **Desirable Criteria**

- · Full driving licence.
- · Millinery.
- Previous experience of working in a busy theatre Costume Department.
